**Bishop Joseph Tyson**— On Thursday, April 8, Bishop Joseph Tyson met with the priests from the Benton County Deanery. We had lunch with the Bishop, and he met with each of us individually. Please keep Bishop Tyson and all the clergy in your prayers.

**Confirmation**— On Saturday, April 10, Bishop Tyson confirmed more than 100 students in our parish! I want to express my sincere gratitude to the many volunteers who assisted with the Confirmation programs in Spanish and English. I had the opportunity to visit the classrooms, and the young men and women were well-prepared to receive the sacrament.

**COVID 19 Vaccines** — We received prayer cards and bookmarks from our Diocese to be distributed on Sunday, April 11. These will help us promote vaccinations and pray for an end to the COVID-19 pandemic. Let us pray so that we can all work together to promote the common good of our community through the mass vaccination efforts underway. This effort will also help us re-open our parishes, schools, and agencies more fully. If you have any questions or concerns about the vaccines, please read the following: On March 2, Bishop Kevin C. Rhoades of Fort Wayne-South Bend, chairman of the U.S. Conference of Catholic Bishops' (USCCB) Committee on Doctrine, and Archbishop Joseph F. Naumann of Kansas City, Kansas, chairman of the USCCB's Committee on Pro-Life Activities, issued a statement on the Johnson & Johnson COVID-19 vaccine recently approved for use in the United States. "The approval of Johnson & Johnson's COVID-19 vaccine for use in the United States again raises questions about the moral

permissibility of using vaccines developed, tested, and/or produced with the help of abortion-derived cell lines. Pfizer and Moderna's vaccines raised concerns because an abortion-derived cell line was used for testing them, but not in their production. The Johnson & Johnson vaccine, however, was developed, tested, and is produced with abortion-derived cell lines raising additional moral concerns. The Congregation for the Doctrine of the Faith has judged that 'when ethically irreproachable Covid-19 vaccines are not available ... it is morally acceptable to receive Covid-19 vaccines that have used cell lines from aborted fetuses in their research and production process.' However, if one can choose among equally-safe and effective COVID-19 vaccines, the vaccine with the least connection to abortion-derived cell lines should be chosen. Therefore, if one has the ability to choose a vaccine, Pfizer or Moderna's vaccines should be chosen over Johnson & Johnson's. While we should continue to insist that pharmaceutical companies stop using abortion-derived cell lines, given the world-wide suffering that this pandemic is causing, we affirm again that being vaccinated can be an act of charity that serves the common good."

**Parish Staff** — Two of our staff members have been infected with COVID-19 recently. I am keenly aware that we are all tired of COVID-19 protocols. Some parishioners are physically and emotionally exhausted. But, please, let us keep wearing our masks and practicing social distancing when we are in public areas and especially when we are at Mass and church events. We are almost there. If you are not vaccinated yet, I encourage you to get vaccinated so that we all will be protected and safe.
